This document constitutes a contract for travel services between individual students who are part of the Hope Christian School tour group and OneLife Tours Ltd. Please read all terms and conditions and the disclaimer carefully before signing.

Terms and Conditions

Tour price guarantee: The fixed price of this tour is \$4250 Canadian dollars.

Included in the price of each tour: *Transportation* including airfare from Calgary to Brussels and London to Calgary, charter bus with English speaking driver in Belgium and France, Eurostar train from France to London, transit pass in London, all accommodations, all breakfasts and dinners, all guide fees and entrances, all gratuities.

Tour payments: To reserve a seat on this OLT tour you must agree to these Tour Conditions and provide us with a first payment of \$500 per person (\$200 of which is non-refundable) by Sept. 30, 2019. We accept cheques payable to OneLife Tours and e-transfers. The first payment should be by cheque made out to OneLife Tours or e-transfer to craig@onelifetours.ca. Payments by cheque or transfer must reach our office by the following dates:

Travel / Medical insurance: Travel/Medical insurance is not part of the travel package price. Participants must purchase their own travel/medical insurance. By signing this document, you acknowledge that you will purchase your own travel/medical insurance for this trip.

Returned payments: If a payment to OneLife Tours is returned unpaid for any reason, we will assess a \$35 returned-item fee per occurrence. The fee(s) will be added to the applicable tour balance and must be paid in full prior to your tour departure.

Cancellations and refunds: Each student's initial payment is subject to a \$200 cancellation fee if the student withdraws. Any withdrawal from the trip after October 31, 2019 for any reason is subject to a \$500 cancellation fee as well as all non-refundable costs associated with planning the trip to that point (a detailed list of non-refundable costs will be provided with the refund). Non-refundable costs could include pre-booked accommodation fees, pre-purchased tickets to attractions, and airline / train fare cancellation fees.

Cancellations must be in writing: sent via email to craig@onelifetours.ca, or mailed to the address below. Cancellations become effective on the date received by OneLife Tours.

Tour forms, obligations, and risks: To travel on a tour, all tour members are required to sign and return a Release and Waiver Agreement prior to the beginning of a tour. Omitting important information, or altering the Release and Waiver Agreement, will render it invalid.
